1. Membership Overview

TopStroke's Monthly Membership is an all-access pass that provides members with:

- Unlimited Mini Golf for the duration of the active membership.
- 2 Slushie Vouchers per Child Member per month.
- 10% Discount on all food and beverage purchases.
- Access to Members-Only Happy Hours and Social Events.
- 20% Discount on all social events booked by members.
- Family Membership Options for households.

2. Membership Types & Pricing

Membership Type	Price (per month)
Adult Membership	\$40
Child Membership	\$25

Family Membership (2 Adults + 2 Kids) \$130

*Prices are subject to change with notice. Additional children can be added to a Family Membership at a discounted rate.

3. Membership Benefits

a) Unlimited Mini Golf

- Members can enjoy unlimited rounds of mini golf during standard operating hours.
- Membership is for 30 days from the date of purchase.
- No reservations required, though wait times may apply during peak hours.

b) Slushie Vouchers (Kids Only)

 Each child member receives two (2) complimentary slushie vouchers per calendar month. • Vouchers are non-transferable and do not roll over to the following month.

c) Discounts

- 10% Off Food & Drinks: Valid for in-store purchases only.
- 20% Off Social Events: Discount applies to event bookings made during an active membership period.

4. Payment & Billing

- Membership fees are charged monthly.
- Payment is due on the date of purchase.
- Unlimited Monthly Memberships are for a 30-day period from the time of purchase. To extend any Membership, an additional payment for each 30-day period is due on the commencement of the new date.

5. Cancellation Policy

- Members may cancel at any time with no cancellation fee.
- No refunds or partial credits will be issued for unused time.
